# **Appointment**

SLC hereby appoints the EA as its non-exclusive representative **Worldwide** for the purposes of providing Study Abroad Advising Services for students who wish to study in Canada at St. Lawrence College.

#### **Term**

This Memo of Understanding will be in effect from <u>June 8<sup>th</sup>, 2020</u> until <u>December 31<sup>st</sup>, 2020</u>. The MoU will be reviewed annually and will remain in effect <u>provided</u> students continue to be successfully enrolled in each subsequent year on referrals from the EA. If no students are enrolled within a calendar year, the MoU will lapse. Notwithstanding the above, the MoU may be terminated by either party at least ninety (90) days prior to the expiration of the initial term or any Renewal thereof, by written notice of one party to the other.

#### **Status of Education Advisor**

The status of the Education Advisor shall be that of an independent contractor and the EA shall have no authority to assume or create any obligation whatsoever, expressed or implied, in the name of SLC, nor to bind SLC in any manner whatsoever. Without limiting the generality of the foregoing, the EA shall have no authority to enter into any contract on behalf of SLC, including any contract or agreement for the provision of educational services by SLC to a potential student or otherwise.

# **Expenses**

All expenses in connection with the EA's performance under this MoU and of his or her activities as an EA, including but not limited to travel, automobile, salaries and supplies shall be borne by the EA and the EA shall be solely responsible for the payment thereof.

# **Acceptance of Applications**

SLC reserves the right to accept or reject, at its sole discretion, any and all Applications for Enrolment whether received as a result of the provision of Recruitment Services by the EA, or otherwise.

As an official agent for St. Lawrence College, any content and imagery provided to you by St. Lawrence College is authorized only for the sole purpose of marketing St. Lawrence College.

# Obligations of SLC

#### INDIAN SUBCONTINENT:

For every qualified applicant accepted by SLC directly referred by the Agent, SLC shall pay to the Agent a <u>flat</u> <u>commission rate</u> according to the following table for the period starting <u>from 1 May, 2020</u>:

Program	Commission
a) English For Academic Purposes (ESL/EAP)	425.00 per 7 week session 850.00 per 14 week session
b) Full-time Academic Programs	850.00 per semester (first 2 semesters only)
c) Business Analytics International	1050.00 per semester (first 2 semesters only)

The payment of commission for the full-time ESL/EAP program (a) will be made for each 7 or 14 week session.

The payment of commission for full-time academic programs (b) will be made for the first academic year only for a total of two semesters, in which tuition is paid.

In the event of students who are enrolled in <u>both</u> the ESL/EAP program (a) and a full-time academic program (b), commission will be paid for the <u>entire duration of the ESL/EAP program</u>, plus the first 2 semesters of the full-time <u>academic program</u>.

Note: All applicants from Bangladesh, Nepal, Pakistan and Sri Lanka need to be processed by our SLC India Office.

## AFRICA:

For every qualified applicant accepted by SLC directly referred by the Agent, SLC shall pay to the Agent a <u>flat</u> **commission rate** according to the following table:

Program	Commission
a) English For Academic Purposes (ESL/EAP)	450.00 per 7 week session
a) English For Academic Furposes (ESE/EAF)	900.00 per 14 week session
b) Full-time Academic Programs	900.00 per semester (first 2 semesters only)

The payment of commission for the full-time ESL/EAP program (a) will be made for <u>each</u> 7 or 14 week session.

The payment of commission for full-time academic programs (b) will be made for the first academic year only for a total of two semesters, in which tuition is paid.



In the event of students who are enrolled in <u>both</u> the ESL/EAP program (a) and a full-time academic program (b), commission will be paid for the <u>entire duration of the ESL/EAP program</u>, plus the first 2 semesters of the full-time academic program.

Note: All applicants from Africa need to be processed by our SLC Africa Office.

## COMMISSIONS FOR COUNTRIES OTHER THAN AFRICA AND THE INDIAN SUBCONTINENT:

For every qualified applicant accepted by SLC directly referred by the Agent, SLC shall pay to the Agent a commission on the **Net Tuition** according to the following table:

Program	Commission
a) English For Academic Purposes (ESL/EAP)	25% per 7 week session
	25% per 14 week session
b) Full-time Academic Programs	20% per semester (first 2 semesters only)

The payment of commission for the full-time ESL/EAP program will be made for each 7 or 14 week session.

The payment of commission for full-time academic programs (b) will be made for the first academic year only for a total of two semesters, in which tuition is paid.

In the event of students who are enrolled in <u>both</u> the ESL/EAP program (a) and a full-time academic program (b), commission will be paid for the <u>entire duration of the ESL/EAP program</u>, plus the first 2 semesters of the full-time academic program.

NOTE: Special May intake tuition is paid in May and January, therefore commissions are only eligible in those semesters.

Payment by SLC to the Recruitment Agent shall be conditional upon the Student, whose Application for Enrolment is accepted by SLC, remaining enrolled at SLC past the refund period established by SLC from time to time and shall be made, in the amount determined, within 30 days following date on which such condition has been satisfied, usually ten days after the start of a semester.
