

## **AMENDING AGREEMENT**

**THIS AMENDING AGREEMENT** (the "Agreement") made as of March 26, 2021.

### **BETWEEN:**

**YORKVILLE UNIVERSITY / TORONTO FILM SCHOOL**

(hereinafter called "**Yorkville**")

and

**Sia Immigration Solutions Inc.**

(hereinafter called "**Agency**")

### **RECITALS:**

1. Yorkville and Agency entered into a representation agreement (the "Representation Agreement"), whereby Yorkville appointed Agency as an educational program recruitment representative, subject to the terms and conditions set out therein.
2. Yorkville wishes to add the Bachelor of Creative Arts program as a new program in connection with which the Agency may now be eligible to receive a commission, subject to the terms and conditions set out herein.

NOW THEREFORE this Agreement witnesses that for good and valuable consideration, the receipt and sufficiency of which are hereby mutually acknowledged, Yorkville and Agency agree as follows:

1. Unless otherwise specifically defined herein or the context otherwise requires, each capitalized term used in this Agreement which is defined in the Representation Agreement has the meaning assigned thereto in the Representation Agreement.
2. Schedule A of the Representation Agreement is deleted in its entirety and replaced with the Schedule A attached hereto.
3. Schedule B of the Representation Agreement is deleted in its entirety and replaced with the Schedule B attached hereto.
4. The Representation Agreement, as amended by this Agreement, continues in full force and effect and is hereby confirmed by the parties hereto.
5. This Agreement shall be construed in accordance with and governed in all respects by the laws of the Province of Ontario and the laws of Canada applicable therein.
6. This Agreement may be executed in one or more counterparts, each of which counterparts so executed shall constitute and be deemed to be an original and all of which together shall constitute one and the same agreement.
7. This Agreement shall ensure to the benefit of and be binding upon the parties hereto and their respective successors and permitted assigns.
