

Client has limited/no declared family in home country; strong pull factors to Canada. Client is wanting to be accompanied by spouse to stay with their only son living in Canada.

Client has had several applications since 2012 for WX-1 or Religious worker visas and has applied for VR's (extensions) on 2 occasions, the first of which was granted in 2014 and the client was compliant with getting an IME within the 90 days and the 2nd was in late 2014 and subsequently refused in 03/2015. After that refusal the client then applied in 2015 and was refused for misrepresentation for failing to declare a US visa refusal for misrepresentation and was subsequently banned for 5 years. That ban has now expired. Given the numerous previous WX-1 applications, attempts to stay within Canada longer with the use of VR's or to enter the US, I am not satisfied the client will adhere to the terms and conditions imposed as a temporary resident with a PG-1.
