

- All international students must have a valid Study Permit from a Canadian Consulate/Embassy to study at Yorkville University.
- All Study Permit applicants must record the Yorkville University Designated Learning Institution (DLI) Number on their study permit application. (Note that the first character of the DLI number is a capital letter O and not a zero).
- You must submit a copy of your valid Study Permit and your Canadian address and phone number to your Admission Advisors prior to the first day of class.
- If you plan to commence program online until transit to Canada is possible for on-campus studies, please discuss with your Admissions Advisors about the appropriate visa status documents to submit before your first day of online classes.

Working While Studying

Post-Graduation Work Permit (PGWP)
