Your acceptance is valid **only** if you meet the following outstanding requirement(s):

- Bring your original study permit to the [International Student Centre](#) (Burnaby, SW1-1170) at least 7 days before your program starts

Contact your Admissions Officer immediately if you are unable to meet the requirement(s) by the date indicated

What Happens Next:

1. We will:

- register you into your first term courses
- notify you of your registration via your mybcit account
- notify you, via your mybcit account, about the orientation day for international students
- notify you, via your mybcit account, about your program's orientation day (for all students)

2. You will:

- pay your [first term tuition fees](#) (\$1,000 of which is non-refundable, non-transferrable), plus the mandatory [U-Pass fees \(\\$164\)](#) and the mandatory 90 days [medical insurance \(\\$180.00\)](#) by: **July 6, 2018**. Once the payment is processed, **the official letter required to obtain your study permit** from Immigration, Refugees and Citizenship Canada (IRCC) will be emailed to you
 - bring your original study permit to the ISC (SW1 - 1170) at least 7 days before your program starts

Medical Insurance:

[Medical insurance](#) is mandatory for the duration of your studies and you are **legally required to apply for Medical Services Plan (MSP)** when you arrive in BC. There are 2 types of insurance:

1. Basic insurance: BC government-run MSP, which *you must apply* for. You will be charged and registered automatically for 3 months of temporary Guard Me insurance (\$180) to cover you during the 3 month MSP waiting period

2. Extended insurance: BCIT Student Association Health and Dental Plan covers what MSP does not. You will be charged and registered automatically each term as part of your tuition fees

Please note: BCIT does not accept credit card payments for tuition or rent.

Please include your student ID number with payment. Allow three (3) business days processing time in order to meet your tuition deadline. Cheques and money orders should be payable to BCIT.

Housing:

[Student Housing](#) provides on-campus housing at Maquinna Residence and support in finding off-campus housing. The residence application deadline is June 1st for programs starting in September. Accommodation is limited and not guaranteed. Contact housing@bcit.ca if your program is less than four months long, or the format is not September to May.
