If you have not already done so please send your official transcripts and proof of graduation from high school. If you are applying for a post graduate program we require original official transcripts from your post-secondary institution and proof of 3 or 4 year bachelor/undergraduate degree from an accredited institution. TRU will verify the accreditation of all post-secondary institutions. Assigned transfer credits are at the discretion of TRU. Submission of high school transcripts is not required for post graduate programs. Please send all admission documents to International Admissions.

# Photocopies or scanned copies of transcripts are sufficient for admission only. However, to begin your studies in academic courses you must submit official original transcripts. Verified copies that come directly from your previous institution are acceptable. Notarized copies are not acceptable.

# TRU English Requirements for direct entry to academic programs

Students must provide **one** of the following:

- BC English 12 with a 73% on combined English 12 and Government Exam in the last 5 years
- completion of English 0600
- completion of TRU's ESAL 0570 and ESAL 0580 with a grade of C+
- current TOEFL Test results with a minimum of 88 (IBT) with no section below 20
- minimum current IELTS of 6.5 (no band below 6.0)
- TRU approved equivalent (link)

Students with an official test score that do not meet direct entry requirements are eligible to write the English placement test. TRU will use the highest score achieved. If you do not have any of the above listed English proficiency scores you <u>will</u> be required to write a test upon arrival.

Students who do not meet direct English requirements will be placed into ESL courses.
