Appendix I

Scholarship and Placement Details

Scholarship details and policies:

1. Scholarships and Study Grants awarded apply to the university degree programs only. The scholarship offer is only valid for the degree shown in the Letter of Offer.
2. **If a student is placed in the Pre-University Program (PUP) based on the results of the required English Placement Test, it could result in adding additional courses to the prescribed degree program**
3. Scholarships are awarded for the academic year for full-time students only.
4. Scholarships are renewable for each academic year, for the life of the student's program, contingent upon successful academic performance.
5. Scholarships may not be used at another institution.
6. Scholarships are subject to adjustment depending on the transfer credits plan (if applicable).
7. *Scholarships awarded prior to High School completion are contingent upon successful High School completion and sustainability of grade point average presented at time of application.*

Academic Placement Details

1. **The FDU Academic Writing test** is mandatory for all new arriving students regardless of the English Test results provided at Admission. Fairleigh Dickinson University uses the English Placement Test (EPT) to evaluate a student's ability to write effectively at an academic level. The test score is based on how well the student can write an argumentative essay in which they present a point of view and support it with appropriate evidence. The test results are recorded on a 18-points scale: Content, Organization, Language Use. Each category is scored using a 6-point scale ranging from minimal evidence (1) to full evidence (6). On the Vancouver campus, applicants must score 15 or higher in order to be placed into the regular academic program without conditions.

Students who score between 11.5 and 14.0 in the placement test are placed in the Pre-University English for Professional Success, a 6 credit course that can be taken concurrently with degree level courses in the first term. Students who score 14.5 are placed directly in the program with the condition of taking additional English support from the Writing Center. Students who score below 11.5 will be required to take additional language classes through our Pathway Schools in Vancouver.

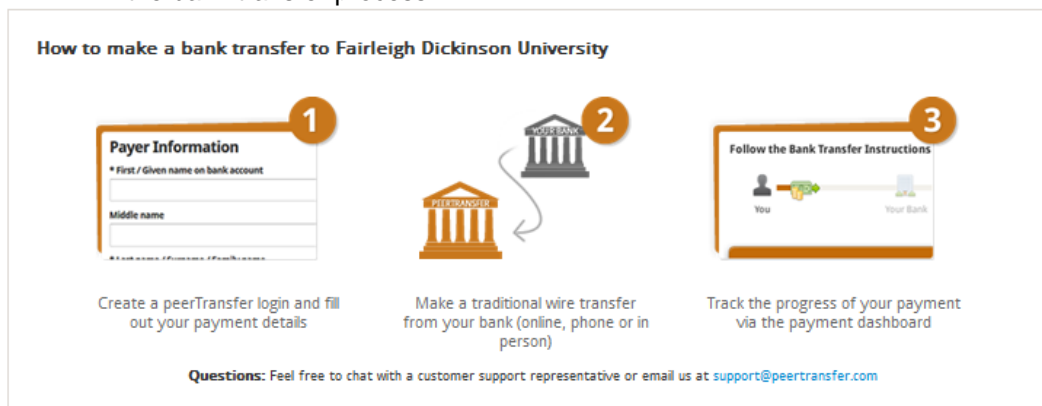
