- CAEL score of 50

Direct entry to ESL High Intermediate (040) with proof of the following:

• overall IELTS Band score of 5.5 with no band less than 5.0.

We offer 3 semesters each academic year that you may choose to begin your ESL studies from: Winter, Spring/Summer, and Fall. The semester you choose will determine the Registration Deadline you must contact us by.

ENGLISH LANGUAGE PROFICIENCY REQUIREMENT FOR ADMISSION TO UNDERGRADUATE PROGRAMS

The language of instruction at the University of Regina is English. All applicants to the University of Regina must therefore demonstrate an appropriate level of proficiency in the English language. The following will be accepted as satisfactory evidence:

- Successful completion of at least three years of formal, full-time English at a secondary school that is a recognized school or institution where English is primary language of instruction.
- Successful completion of the English as a Second Language (Advanced EAP) program or a minimum average score of 55 on the ESL placement exam both offered through the Centre for Continuing Education at the University of Regina. - Successful completion of at least 24 credit hours (University of Regina degree level equivalent) in an approved English-language post-secondary institution, including at least 6 credit hours in humanities or social science subjects and with a minimum grade point average of 60.00% or equivalent.
- Advanced Placement English (grade of 3 or better) or International Baccalaureate Higher English (grade of 4 or better) or SAT II English (required score varies).
- GCSE/IGCSE/GCE O' Level English, English Language, or English as a Second Language with minimum grade of 'B' or GCE A/AS/AICE Level English or English Language with minimum grade of 'C'.
- One of the following valid tests will also be accepted. Test results must be received by the Admissions Office directly from the testing service before the deadline for receipt of application documents.
