## PAYMENT OPTIONS:

Sault College uses CIBC International Student Pay for all international payments made from accounts outside of Canada. Please use the CIBC International Student Pay secure online platform at <https://pay.cibc.com/sault>. You will receive a quote in your local currency and can choose from the following payment options: bank wire; Visa and MasterCard, China UnionPay, or ACH Direct Debit. Once your fees have been processed by our Financial Services Department, we will upload a copy of your receipt on your application portal.
