In addition to the above requirements, please note that official transcripts will be required in the following circumstances: to register in senior-level courses, transcript(s) must reflect completion of 18 acceptable junior-level credits; to register in senior-level courses, transcript(s) must reflect completion of required prerequisite(s); if you have completed a degree program, you may be eligible to take 15 credits per semester to a lifetime maximum of 30 credits in Open Studies, provided the official transcript from the institution where the degree was obtained is received by Concordia.

Transcripts will be sent on your behalf for Alberta Education and post-secondary institutions that subscribe to ApplyAlberta. You must arrange to have all out-of-province and international transcripts sent directly from the issuing institutions to the Admissions Office.
