Study Permit Approval

To confirm your seat, you **must submit proof of your valid study permit approval** to the <u>International Education Office</u> at VCC by <u>July 15, 2020</u>. You may submit a copy of your study permit, a copy of your IRCC approval letter or a copy of your Temporary Resident Visa (TRV) for Student status. Failure to submit proof of approval by this date may result in your seat being offered to another student. If your Study Permit is in process or not approved by this date, you may be deferred to the next available intake.



Meeting Conditions

If you are unable to meet the conditions of your admission by the stated deadlines, you may request a <u>deferral</u> of your application to the next available term. Deferral requests must be received a minimum of six weeks prior to the start date of your program.

Submission of Official Original Documents

Prior to the start date of your program, you must also submit official original documents to the International Education office. Failure to submit all official original documents will impact your registration for future terms.
