Study Permit Application

Once you have accepted this offer, you must apply for (or extend) your Study Permit from Immigration, Refugees and Citizenship Canada as soon as possible. To apply, you will require proof of acceptance to VCC. This Letter of Offer is your official letter of acceptance that you must use for your proof of acceptance in your Study Permit application. You will also be required to submit proof of payments to VCC. If you pay VCC by Flywire, you can print your payment receipt right away from the Flywire dashboard. If you pay VCC using another method, VCC will email you your payment receipt when the payment has been processed.



Study Permit Approval

To confirm your seat, you **must submit proof of your valid study permit approval** to the <u>International Education Office</u> at VCC at by <u>November 15, 2021.</u> You may submit a copy of your study permit, a copy of your IRCC approval letter or a copy of your Temporary Resident Visa (TRV) for Student status. Failure to submit proof of approval by this date may result in your seat being offered to another student. If your Study Permit is in process or not approved by this date, you may request a deferral to the next available intake.

Submission of Official Original Documents

Prior to the start date of your program, you must also submit official original educational documents to the International Education office. Failure to submit all official original documents will impact your registration for future terms.

Fees, Payments and Fee Increases

Tuition and other fees are approximate and subject to annual increases. Other fees and charges may apply. All fees may change without notice. Students will be required to pay increased rates if the fees change at any time during the period of enrolment in the program. For more information about fees and payments, visit our website.
