  - August 15 (September/Fall programs)
  - December 15 (January/Winter programs)
  - April 15 (May/Summer programs)
4. You are required to arrive on campus at least 1 week prior to the start of term to attend the mandatory International Student Orientation. Failure to do so may result in removal from your program.
