- Pay your estimated first-year tuition fees (includes non-refundable tuition deposit of \$5,000.00 CAD for the first certificate and non-refundable tuition deposit of \$1,500 CAD for the second certificate) if you plan to apply for a study permit through a SDS <u>Student Direct Stream</u>. Study Permit Application

Once you have accepted this offer, you will receive your official Letter of Acceptance (LOA) from VCC via email that can be used to apply for or extend your Study Permit and Co-Op Work Permit from Immigration, Refugees and Citizenship Canada (IRCC). Please apply as soon as possible after receiving your LOA.

Study Permit Approval

To confirm your seat, you must submit proof of your valid Study Permit approval to the International Education Office by November 15, 2023. You may submit a copy of your Study Permit, a copy of your IRCC Study Permit approval letter, or a copy of your Temporary Resident Visa (TRV) for Student status. Failure to submit proof of approval by this date may result in your seat being offered to another student. If your Study Permit is in process or not approved by this date, you may request a deferral to the next available intake. If you have already submitted this to us, thank you. You do not need to re-submit to us.

Submission of Official Original Educational Documents

Admission to VCC is based on scanned or photocopied educational documents. Original official educational documents are required for final verification. Prior to the start date of your program, you must submit your official original hard-copy documents to the International Education office. If you do not submit your original documents to VCC, you will be blocked from registering or attending future terms and you will not be eligible to graduate from your VCC program.
