In accordance with the Tuition and Fee guideline set by the Government of Alberta, the University of Lethbridge has estimated the following tuition maximums for international students. Tuition maximums are guaranteed provided you remain enrolled, for the standard duration of your intended program, assuming a 100% standard course load of required courses each term. Tuition maximums do not include other fees such as textbooks, non instructional fees, mandatory health and dental fees and living expenses and hence it does not reflect amounts owing. A standard course load is 30 credit hours (10 three-credit courses) per academic year as reflected in the following table.

2023 – 2024	\$21,500.00
2024 – 2025	\$22,600.00
2025 – 2026	\$23,700.00
2026 – 2027	\$24,900.00
2027 – 2028	\$26,200.00
2028 – 2029	\$27,500.00
2029 – 2030	\$28,900.00
