We are pleased to offer you conditional admission as a full-time international student to the above program and intake. The condition of your admission is:

• Submit Food Safe Level 1 Certificate by 01-Dec-2023. VCC requires the submission of the final official certificate to meet the condition. Food Safe Level 1 certificate processing time is approximately 4-6 weeks after completing the course.

To accept this offer, you must do one of the following by November 9, 2023:

- Make a \$15,950.00 CAD deposit payment towards your first term via Flywire (includes non-refundable tuition deposit of \$5,000.00 CAD); or,
- Pay your estimated first-year tuition fees via <u>Flywire</u> (includes a non-refundable tuition deposit of \$5,000.00 CAD) if you plan to apply for a study permit through an SDS <u>Student Direct Stream</u>. The payment deadline is the same date stated above. Estimated first-year fees per program can be found on our <u>International Tuition Chart</u>.
- If you need an extension to the payment deadline, please contact ieadmissions@vcc.ca before the deadline. The extension is no guaranteed. The possible extension is only available upon approval based on seat availability and the requested extension
- After you pay the standard tuition deposit, an LOA will be issued. If additional payments are received after the initial LOA is issued, you may apply for your SDS Student Direct Stream with the initial LOA and include the payment receipts for all payment. No updated LOA will be re-issued.

VCC International only accepts payments made via <u>Flywire.</u> Deposit payments received by VCC via any method other than <u>Flywire</u> will be rejected and returned to the sender. Returned deposits will have Administrative Fees and Wire Transfer Fees deducted from the returned amount. Seats in VCC programs are only held for students who make their tuition deposit payments via <u>Flywire</u>.

Study Permit Application

Once you have accepted this offer, you will receive your official Letter of Acceptance (LOA) that can be used when applying for or extending your Canadian Study Permit and Practicum [Co-Op] Work Permit from Immigration, Refugees and Citizenship Canada.

Study Permit Approval

To confirm your seat, you must submit proof of your valid study permit approval to ieadmissions@vcc.ca by November 15, 2023. You may submit a copy of your Canadian Study Permit, a copy of your IRCC Port of Entry (POE) letter, or proof of Study Permit extension submission confirmation prior to the original study permit end date. Failure to submit proof of approval by this date may result in your seat being offered to another student. If your Study Permit is in process or not approved by this date, you may be deferred to the next available intake. If you have already submitted your Study Permit approval to us, thank you - you do not need to re-submit to us.

Meeting Conditions

If you are unable to meet the conditions of your admission by the stated deadlines, you may request a <u>deferral</u> of your application to the next available term. Deferral requests must be received a minimum of six weeks prior to the start date of your program.
