- 1) Apply for your study permit, using all pages of this acceptance package, as soon as possible. Please email us your IRCC visa application confirmation letter no later than ONE month from the date of this letter. - 2) See Section 24 on the attached IRCC form. If that section states "Required", you should also apply for a "co-op work permit", with your study permit application. Answer "yes" to the question on the application about "work that is an essential/integral part of your program".
- 3) Pay a \$2,500 non-refundable/non-transferrable tuition deposit by NOVEMBER 30, 2023. Your seat will be cancelled if the college does not receive the deposit(s) by the deadline(s). See <a href="http://assiniboine.net/internationalpayment">http://assiniboine.net/internationalpayment</a> for payment method and receipt information.
- 4) Email us your study permit decision (approval or refusal) as soon as you receive it. Your seat will be cancelled if you do not provide this decision THREE months before your program start date.
- 5) After you arrive in Canada, you will be required to submit your original, official (hard copy) transcripts, language scores and study permit to our Assiniboine International office on campus at 1430 Victoria Avenue East, Brandon. The deadline for this is the **first day of classes**.

Tuition fees on the attached IRCC form are estimated and can change without notice. Fees may increase by 5 to 10%. Program information is available on each program's webpage. Search your program name on <u>assiniboine.net/programs</u> and click on "Courses and Costs" to see tuition and other required costs associated with your program, including:

- Mandatory health insurance: plan for \$1,000 (estimated).
- Books and/or supplies: see your program's webpage and click on the "Tools & Supplies" button.
- Some programs require you to have specific computer equipment and it is your responsibility to prepare assiniboine.net/tech.

You should plan to arrive the week prior to your classes beginning in order to attend New Student Orientation. Further details about this orientation will be communicated to you closer to your program start date.

A refund of your tuition paid (minus a \$150 processing fee) is available only if you apply for your study permit quickly after acceptance, and IRCC denies your study permit application before the first day of your program.

You will receive registration information after you have paid fees by the deadline(s) above and have sent us proof of study permit approval, but no earlier than eight weeks prior to program start date. To help you prepare, we encourage you to download our International Handbook at assiniboine.net/pre-arrival.
