- 3. Course registration:** [Register](#) as soon as possible since courses may fill very quickly. Course registration is on a first-come-first-serve basis. We will send your list of required courses (program matrix) separately. Ensure that you maintain your [academic status](#) according to IRCC requirements. Confirm upcoming [registration dates](#) for future terms to plan ahead.
- 4. Tuition payment:** [Tuition for Flexible Learning courses](#) is due immediately upon registration. Check your [account balance](#) once you've registered. **If the amount owing is more than your \$6000.00 tuition deposit, pay the difference immediately to avoid being dropped from your course(s).** Your tuition deposit will be released to your account within 2 business days of course registration.
- 5. IRCC letter:** Approximately 2-3 weeks after receiving your tuition deposit, we will send your official acceptance letter required by Immigration, Refugees and Citizenship Canada (IRCC) for study permit application. Access your IRCC letter in [myCommunication](#).
- 6. Study permit application:** Submit your study permit application to IRCC as soon as possible. Visit our [Study Permits](#) page to learn more about the process.
- 7. Study permit:** Meet [BCIT's study permit requirement](#). Send a clear image of your study permit to [statusdoc@bcit.ca](mailto:statusdoc@bcit.ca) from your myBCIT email account as soon as you receive it. Please include your BCIT ID number. You must provide your study permit by **March 26, 2024**.
- 8. Refund policy:** Review [BCIT's refund and withdrawal policy for Flexible Learning courses](#). If you need to transfer or drop one or more courses for any reason, you are responsible for submitting your request by

the applicable deadlines.
