International Students who cancel their enrolment, for any reason, before the commencement of the classes will receive a refund of any pre-paid tuition fee collected less the registration fee of \$250.

In case of Visa refusal, IBU will provide a full refund (excluding the registration fee of \$250) upon receiving a copy of Visa Refusal Letter from Canadian Immigration Office (IRCC). All such refunds must be submitted by the end of week 2 of the beginning of the semester.

You will need to secure your place in the program with a payment towards your tuition fees. Such payment must be received within 20 working days of receipt of this letter. To guarantee your spot, please refer to the tuition fee payment methods below.

You may be eligible for Transfer Credits based on prior learning (conditional upon successful completion certificate and official transcripts and subsequent evaluation)

### Official Transcript Submission

Students must submit their official transcripts by the start of their first term. Non-receipt of an official transcript will result in a hold being placed on the student record and registration into classes denied.

An official document is defined as an original (or attested) copy being received directly from the institution of issuance without interference. This means that your transcripts must be issued by the educational institution in a sealed envelope bearing the original institutional seal, stamp, or signature. Do not open it. You may then bring this envelope to the Registrar's Office at International Business University when you arrive to register.

Opened transcripts, photocopies, faxed copies, and certified/notarized copies are not acceptable and should not be submitted. Third party evaluations such as those provided by credential evaluation services will not be accepted in place of official transcripts.

Official documents required:

- Official transcripts issuing authority.
- Proof of Language Proficiency (undertaken in last 2 years), if required.

<b>Step 2</b>	Once your application is completed, your file will be submitted for consideration by the Admissions team at International Business University. They can only evaluate applications with the following documents included: <ul style="list-style-type: none"> <li>Official Transcripts of all secondary and post-secondary institutions attended.</li> <li>Letter of Intent.</li> </ul>

	<ul style="list-style-type: none"> <li>• International Business University may request foreign transcripts to be evaluated by a IBU approved international credentialing service such as WES, ICAS.</li> <li>• English proficiency test score result i.e. IELTS, TOEFL, Duolingo, etc.(See detailed list of accepted tests on our website). Score - must be within two years.</li> <li>• GMAT or GRE Score (applicable for MBA program only)</li> </ul>
<i>Step 3</i>	A decision is made and communicated to you from IBU Registrar's Office. At that point, accepted students will need to then pay their deposit in order to receive their final Letter of Acceptance and start your study.
<i>Step 4</i>	Once you have received your Letter of Acceptance, you will need to work towards paying the balance of your remaining tuition fees. It should be noted that as a IBU student you are obliged to pay each term's tuition fees before the start of each term.
<i>Step 5</i>	Details of the timetable and orientation session will be sent about one month prior to the start date and International Business University will look forward to welcoming you on campus to the <i>Master of Business Administration (Global Business Management) program</i> .
