- Pay your estimated first-year tuition fees (includes non-refundable tuition deposit of \$10,000.00 CAD) if you plan to apply for a study permit through a SDS <u>Student Direct Stream</u>. Estimated first-year fees per program can be found on our <u>International Tuition Chart</u>.

Refund Policy

Prior to accepting your offer, ensure you have reviewed the <u>International Refund Policy</u> portion of our website. Note that all refunds are issued directly back to the payer in the method used to make the payment. We highly recommend that only students make payments directly to VCC to ensure that in the event of a refund, the funds are refunded directly back to the student. Payment Method and Deadline

To accept this offer, read the refund policy carefully and pay the tuition deposit before the deadline. VCC International only accepts payments made via <u>Flywire</u>. Deposit payments received by VCC via any method other than <u>Flywire</u> will be rejected and returned to the sender. Returned deposits will have Administrative Fees and Wire Transfer Fees deducted from the returned amount. Seats in VCC programs are only held for students who make their tuition deposit payments via <u>Flywire</u>.

If you need an extension to the payment deadline, please contact <u>ieadmissions@vcc.ca</u> before the deadline. The extension is not guaranteed. The possible extension is only available upon approval based on seat availability and the requested extension.

Acceptance

After you accept the offer by paying the standard tuition deposit, a Letter of Acceptance (LOA) will be issued. If additional payments are received after the initial LOA is issued, you may apply for your SDS Student Direct Stream with the initial LOA and include the payment receipts for all payment. No updated LOA will be re-issued.

Study Permit Application

Once you have accepted this offer, you will receive your official Letter of Acceptance (LOA) from VCC via email that can be used to apply for or extend your Study Permit and Co-Op Work Permit from Immigration, Refugees and Citizenship Canada (IRCC). Please apply as soon as possible after receiving your LOA.

Study Permit Approval

To confirm your seat, you must submit proof of your valid Study Permit approval to the <u>International Education Office</u> by **July 15, 2024**. You may submit a copy of your Study Permit, a copy of your IRCC Study Permit approval letter, or a copy of your Temporary Resident Visa (TRV) for Student status. Failure to submit proof of approval by this date may result in your seat being offered to another student. If your Study Permit is in process or not approved by this date, you may request a <u>deferral</u> to the next available intake. If you have already submitted this to us, thank you. You do not need to re-submit to us.
