Refund Policy

Payment Method and Deadline

Acceptance

After you accept the offer by paying the standard tuition deposit, a Letter of Acceptance (LOA) will be issued. If additional payments are received after the initial LOA is issued, you may apply for your SDS Student Direct Stream with the initial LOA and include the payment receipts for all payment. No updated LOA will be re-issued.

Study Permit Application

Once you have accepted this offer, you will receive your official Letter of Acceptance (LOA) from VCC via email that can be used to apply for or extend your Study Permit and Co-Op Work Permit from [Immigration, Refugees and Citizenship Canada](#) (IRCC). Please apply as soon as possible after receiving your LOA.

Study Permit Approval

To confirm your seat, you must submit proof of your valid Study Permit approval to the [International Education Office](#) by **November 15, 2024**. You may submit a copy of your Study Permit, a copy of your IRCC Study Permit approval letter, or a copy of your Temporary Resident Visa (TRV) for Student status. Failure to submit proof of approval by this date may result in your seat being offered to another student. If your Study Permit is in process or not approved by this date, you may request a [deferral](#) to the next available intake. If you have already submitted this to us, thank you. You do not need to re-submit to us.
