## CONDITIONS OF ADMISSION

TRU requires the following four conditions be met. If you have already submitted the following documents, please do not re-submit them.

## 1. Provide official or attested transcripts

- Official transcripts must be sent directly from the issuing institution, either by e-mail **or** mail, not both. Please send the attached transcript request form to your previous institutions.
  - Please include certified English translations if your official records are not in English
  - Notarized copies are not acceptable. Attested copies may be accepted only where additional official transcripts cannot be issued.
- 2. Meet TRU English requirements by providing an acceptable English language proficiency score.
  - Students with an official test score that do not meet direct entry requirements may be required to write the TRU English Placement Test (EPT) upon arrival.
  - Students who do not have an official test score will be required to write the TRU English Placement Test (EPT) upon arrival.
  - If you do not meet the academic or English requirements for this program, you will be placed into University Preparation or EAP courses at the time of registration.
- 3. Complete of any outstanding admission requirements as outlined on the program website.
  - Incomplete requirements will require completion at TRU.
- 4. Payment of deposit as outlined in the official invoice on page three by 23 June 2024.
  - **Ensure** you read and understand the <u>new student refund information</u>.



# YOUR NEXT STEPS

- **Confirm** your name, address, date of birth and program are correct and notify us immediately of any errors. You do not need to notify us if it is correct.
- Pay your deposit by 23 June 2024 to receive a final letter of admission.
- **Familiarise** yourself with your <u>myTRU account</u> to ensure all admission requirements are met.
- **Submit** your official or attested transcripts directly from your institution.

# IMPORTANT INFORMATION

## Study Permit and Provincial Attestation Letter (PAL)

- Once we have received your official transcripts and you have accepted this offer letter by paying your deposit, you will receive your final letter of acceptance (LOA) to use when applying for your study permit from <u>Immigration Refugees and Citizenship Canada</u>.
- TRU will issue you a PAL on behalf of the Government of BC after your LOA is issued, if you are eligible.
- It is your responsibility to confirm your <u>Canadian study permit eligibility</u> and Canadian Embassy <u>study</u> <u>permit processing times</u> in your country. **Study permits must be confirmed by August 15, 2024 to** be eligible for registration.
  - Kindly note that we cannot accept copies of study permits, passport requests (PPR) letters, or visa confirmations via email.
  - Please upload your study permit <u>here</u>.
  - Failure to submit the study permit using the link may result in ineligibility to register or defer.
- We reserve the right to defer your admission to the next available semester if deadlines are missed or capacity is reached.

# Housing

- You should wait until you receive your study permit confirmation before booking fights or making significant life changes like leaving your job. If you do so, it is at your risk.
- If you are interested in on-campus housing, we recommend you apply as soon as the residences begin accepting applications. If you are interested in off-campus housing, students find it easier to secure suitable housing when they are in Kamloops already.

### **Tuition Fees**

We encourage you to learn more about tuition fees <u>here</u>. Some programs may have additional fees or require additional courses. Any outstanding balances are the responsibility of the student at the time of registration.

### **General Fees**

General fees are required every semester by all students to cover costs such as library, activity, <u>TRU Student Union</u>, U-Pass (full access pass to City transit) and others.

### Health and Dental

The TRU Student Union operates a mandatory extended health and dental plan that covers health, dental, vision and travel benefits. Learn more about the plan <u>here</u>.

### Medical Insurance and MSP Premium

International students are required to have <u>medical coverage</u> in Canada. For the first three months, students receive coverage through <u>guard.me</u>. After three months, students are required to sign up for the <u>BC Medical Services Plan</u>.

### Housing

TRU offers two on-campus and one off-campus residence, as well as homestay. There are two ways to book a room at the residences. Students can <u>book directly</u> with the residence of choice or through <u>TRU World</u> by submitting the full housing fees, along with the tuition and fees. If you book directly through the residence, TRU World will not be able to access any information to support you with housing. <u>Homestay</u> must be booked through TRU World directly.

There are also off-campus housing options available to students in the Kamloops community. You can find more information on neighbourhoods, where to find rental listings and more on the <u>Off Campus Housing page</u>. Kindly note, it is your responsibility to find suitable housing during your time at TRU and we recommend you start looking for housing early, whether on or off campus.

### **Refunds and Deferrals**

Refunds will be given upon proof of study permit rejection and an administrative charge of \$200 will be deducted. Application fees are non-refundable. We recommend students to be familiar with the <u>New Student Tuition Refund</u> <u>Information</u> prior to submitting a payment. If you are not able to start as planned, you can request a <u>deferral</u>.



## REFUND AND DEFERRAL INFORMATION FOR NEW INTERNATIONAL STUDENTS

# **REFUND OF TUITION DEPOSIT**

Tuition deposits are **non-refundable and non-transferable**. It is the responsibility of the student to read and understand the refund information, important deadlines below, and to plan and budget accordingly.

Students who receive a visa and/or study permit along with a final letter of acceptance, must begin their studies at TRU in the semester written on their letter.

New students who can provide official documentation from IRCC (Immigration, Refugees and Citizenship Canada) indicating that their visa and/or study permit application was denied, are eligible for a full refund of their deposit less a \$200 administrative fee. Documentation must be issued by IRCC later than the current letter of acceptance from TRU.

Requests for refunds due to visa rejections must be submitted prior to the <u>course change period deadline</u> to avoid a deposit forfeit. Thompson Rivers University (TRU) reserves the right to contact IRCC to verify the status of a visa and/or study permit application and/or to verify the contents of a refusal letter.

To submit a refund request:

- 1. Complete the <u>refund request form</u>.
- 2. Submit your refund request form, along with IRCC documentation, to international admissions.
- 3. Wait for an email from <u>PayMyTuition</u> to confirm how you want your refund payment processed.

Refunds may take 4-6 weeks to be processed.

## ADMISSION DEFERRALS

After receiving a letter of acceptance issued by TRU, all new international applicants are expected to begin their studies at TRU in the semester noted in their current letter of acceptance. Students who do not receive a study permit decision prior to the visa confirmation deadline are required to <u>request a deferral</u>.

Students that wish to defer their first semester of study to a future semester may do so only once and up to a maximum of one calendar year (ie. a student accepted to the fall semester may defer until the next fall semester but not later). Students must <u>request a deferral</u> prior to the <u>course change period deadline</u> to avoid a deposit forfeit. After one calendar year, a student must reapply if they wish to commence studies at TRU.
