Refund Policy

Payment Method and Deadline

Acceptance

If additional payments are received after the initial LOA is issued, you may apply for your SDS Student Direct Stream with the initial LOA and include the payment receipts for all payment. No updated LOA will be re-issued.

Study Permit Approval

To confirm your seat, you must submit proof of your valid Study Permit approval to the International Education Office by November 15, 2024. You may submit a copy of your Study Permit, a copy of your IRCC Study Permit approval letter, or a copy of your Temporary Resident Visa (TRV) for Student status. Failure to submit proof of approval by this date may result in your seat being offered to another student. If your Study Permit is in process or not approved by this date, you may request a deferral to the next available intake. If you have already submitted this to us, thank you. You do not need to re-submit to us.

Submission of Official Original Educational Documents

Admission to VCC is based on scanned or photocopied educational documents. Original official educational documents are required for final verification. Prior to the start date of your program, you must submit your official original hard-copy documents to the International Education office. If you do not submit your original documents to VCC, you will be blocked from registering or attending future terms and you will not be eligible to graduate from your VCC program.
