Refund Policy

Payment Method and Deadline

Returned deposits will have Administrative Fees and Wire Transfer Fees deducted from the returned amount. Seats in VCC programs are only held for students who make their tuition deposit payments via <u>Flywire</u>. The possible extension is only available upon approval based on seat availability and the requested extension.

Acceptance

If additional payments are received after the initial LOA is issued, you may apply for your SDS Student Direct Stream with the initial LOA and include the payment receipts for all payment. No updated LOA will be re-issued.

Study Permit Approval

To confirm your seat, you must submit proof of your valid study permit approval to ieadmissions@vcc.ca by November 15, 2024. You may submit a copy of your Canadian Study Permit, a copy of your IRCC Port of Entry (POE) letter, or proof of Study Permit extension submission confirmation prior to the original study permit end date. Failure to submit proof of approval by this date may result in your seat being offered to another student. If your Study Permit is in process or not approved by this date, you may be deferred to the next available intake. If you have already submitted your Study Permit approval to us, thank you - you do not need to re-submit to us.

Note that you are responsible for complying with your study permit conditions. Please visit our website for more information.

Official Original Educational Documents

You must bring all official original educational documents used for admission to VCC with you to Canada. VCC reserves the right to request your educational documents at any time for review.

Fees, Payments, and Fee Increases

Tuition and other fees are approximate and subject to annual increases. Other fees and charges may apply.
