You may submit a copy of your Study Permit, a copy of your IRCC Study Permit approval letter, or a copy of your Temporary Resident Visa (TRV) for Student status. Failure to submit proof of approval by this date may result in your seat being offered to another student. If your Study Permit is in process or not approved by this date, you may request a [deferral](#) to the next available intake. If you have already submitted this to us, thank you. You do not need to re-submit to us.

Consent to Share Personal Information

By accepting your offer to VCC, you acknowledge and agree that the personal information provided in your application will be included in the Provincial Attestation Letter (PAL). You consent to your personal information being shared with the Ministry of Post-Secondary Education and Future Skills (the Ministry) and the federal department of Immigration, Refugees and Citizenship Canada (IRCC) for operational and program evaluation purposes.

Submission of Official Original Educational Documents

Admission to VCC is based on scanned or photocopied educational documents. Original official educational documents are required for final verification. Prior to the start date of your program, you must submit your official original hard-copy documents to the International Education office. If you do not submit your original documents to VCC, you will be blocked from registering or attending future terms and you will not be eligible to graduate from your VCC program.
