Trinity Western University International Student Admission - Tuition Deposit Policy

- 1) International Students (citizenship outside Canada and US) new to Trinity Western University must pay an Admission-Tuition deposit of \$9,990 CAD, less Trinity Western University awarded scholarships for one term. Following receipt of the deposit, the Letter of Admission and VISA form will be issued.
- 2) International Students (citizenship outside Canada and US) new to Trinity Western University who already hold a valid Canadian Study Permit must pay an Admission-Tuition deposit of \$4,552 CAD. Following receipt of the deposit, the Letter of Admission and VISA form will be issued.
- 3) Trinity Western University has partnered with Flywire to provide our international students with a secure payment method that simplifies the payment process. With Flywire, you can pay online from banks and countries around the world, usually in your home currency. To begin your payment, go to https://trinitywestern.flywire.com.

Note: TWU must comply with all applicable banking, regulatory, and legal requirements. If international students submit their tuition deposit via any other method, any refund of such deposit may be subject to delays, especially if they are from students resident in Special Requirement Jurisdictions¹.

- 4) All International Students resident in special requirement jurisdictions¹ ("**Special Requirement Jurisdictions**") must complete the Deposit and Refund Certification for Students Resident in Special Requirement Jurisdictions, attached hereto as Schedule "A".
- 5) Subject to the International Student Refund Policy (below), the deposits described above are non-refundable.

Refund of Admission-Tuition Deposit

Admission-Tuition deposit refunds will only be issued if the student VISA and/or study permit is denied. Students must notify Trinity Western University by emailing registrar@twu.ca and include a copy of the official study permit rejection letter from the Canadian Embassy or Consulate. Students must provide a current mailing address when requesting a refund.

TWU requires that International Students resident in Special Requirement Jurisdictions must complete Schedule "A" (attached).

Deferral of Admission-Tuition Deposit

Admission-Tuition deposits may be deferred to a future semester to a maximum of one year. Notification of deferral must occur prior to the official start date of the semester for which admission has been granted.
