- **Apply for a Study Permit.**
  - As part of your study permit application, you will need a Provincial Attestation Letter (PAL). Once you confirm your offer of admission and pay your \$3,000 tuition deposit, Humber will request a PAL from the Ministry of Colleges and Universities on your behalf. Your PAL will be sent to you from Humber by email within 1-2 business days. You must ensure your study permit application is submitted before your PAL expiration date.
  - To help you submit your study permit application as accurately and easily as possible, Humber has partnered with **BorderPass**, a digital platform offering full study permit support, including legal review and submission by Canadian immigration lawyers, at no additional cost to you beyond standard processing or filing fees. While using BorderPass to file your study permit application is not mandatory, you are encouraged to sign up and access the provided support. **RE: Co-op Work Permit for mandatory component of  
Early Childhood Education (07911)**

This letter confirms that a Co-op /Work Placement/Internship is a mandatory requirement of the **Early Childhood Education** program at Humber College Institute of Technology & Advanced Learning in Toronto, Canada. This letter is to be used as supporting documentation to apply for a Canadian **Co-op Work Permit**; you should apply for your Co-op Work Permit at the same time as you submit your Study Permit application.

This work component requires the completion of **500-600 hours of mandatory field experience over semesters 2, 3 and 4. Students in this program may be required to complete placements in a variety of settings such as childcare centres, nursery schools, school programs, and other early learning and childcare program settings. Students are required to complete a medical exam with a panel physician before applying for a co-op work permit and study permit. Other non-medical requirements are also mandatory before students begin working in an industry related to the field of study.**

This placement is an essential and integral component of the program and forms less than 50 per cent of the total program of study. Successful participation and completion of the internship placement is a requirement for graduation. Before beginning any type of co-op/placement/internship, all students must receive a co-op work permit in addition to their study permit.
