Deferral Policy

If you wish to defer your offer of admission, you may do so once with no questions asked - no formal reason is required.

After your initial request, all subsequent deferrals require that a deposit has been made to your account; you can make as many deferral requests as needed with a deposit on your account. If you've applied with the help of an agent, please submit the deferral request directly through your agent. How to Pay Tuition and Student Fees:

Program Capacity

Algoma University reserves the right to close applications, limit tuition deposits, limit seats in academic programs or change advertised deadlines, without advance notice, in order to manage the capacity of our academic programs. The university will provide alternate options to students, including program changes, campus changes, and intake changes.

Study Permit Application Deadline and Visa Stamp/LOI Deadline

Algoma University requires applicants to submit proof of their study permit application no later than ten weeks before the first day of classes and to submit a copy of their visa stamp or Letter of Introduction (LOI) no later than five weeks before the first day of classes for their scheduled intake. These deadlines are to ensure students have sufficient time to plan for their arrival and so that the university can finalise its class sections and schedules for the beginning of the semester. Applicants who do not meet this deadline may be required to defer their application to the next available intake for their program. Documents can be submitted at https://forms.gle/G9ZJqsTbkDbCFJDE8.

Refund Policy

The tuition deposit will be non-refundable, except in limited circumstances detailed in our International Student Refund Policy.
