The program's format is as follows:

- Level One Master of Education Foundation program (GCES)
 - o Three courses (9 credits):
 - Learning about Learning
 - Writing in a Graduate Context and
 - Research Colloquium
- Level Two Master of Education (30 credits)
 - o Ten EDUC graduate level courses.

Level One Master of Education Foundation courses GCES must be completed with B- or better and ESL courses must be completed with a B or better as a prerequisite for moving to Level Two Master of Education courses.

Please note that TRU's Graduate Certificate in Educational Studies (GCES) and Master of Education (MEd) programs lead graduates to career outcomes in a diverse range of educational settings, but **do not provide a teaching credential**.

In Canada, completion of a recognized teacher education program is required to teach K-12 and be eligible for the Teacher Qualification Service. Your Master of Education credential and official transcripts will state **Master of Education**. For detailed information about the MEd Program or our Bachelor of Education programs, please see the TRU Academic Calendar (<u>Academic Calendar</u>).



CONDITIONS OF ADMISSION

TRU requires the following three conditions be met.

1. Provide official or attested transcripts

- Official transcripts must be sent directly from the issuing institution, either by e-mail **or** mail, not both. Please send the attached transcript request form to your previous institutions.
- Certified English translations are required if your official records are not in English.
- Attested transcripts (copies of your official transcripts that have been stamped and signed by the Registrar
 of the issuing institution) may be accepted only where additional official transcripts cannot be issued.
 Notarized copies are not accepted.
- If your degree is currently in progress, you must send your final official transcripts, including proof your degree was awarded, prior to the start of classes. Failure to provide confirmation of degree will result in a change of program.
- 2. Meet TRU English requirements by providing an acceptable English language proficiency score.
 - Students who do not have an official test score will be required to write the TRU English Placement Test (EPT) upon arrival.
 - Students with an official test score that do not meet direct entry requirements may be required to write the TRU English Placement Test (EPT) upon arrival.
 - If you do not meet the academic or English requirements for this program, you will be placed into University Preparation or English for Academic Purposes (EAP) courses at the time of registration.
- 3. Pay your deposit as outlined in the official invoice on page two by 27 July 2025.

^{*}Effective November 8, 2024, IRCC has ended the Student Direct Stream (SDS) and the Nigeria Student Express (NSE). In response to this change, TRU no longer requires a one-year tuition deposit. For students who choose to pay more than the required deposit, any additional funds will remain in their TRU tuition account for future use.

IMPORTANT INFORMATION



STUDY PERMIT AND PROVINCIAL ATTESTATION LETTER (PAL)

- Once we have received your official transcripts and you have accepted this offer letter by paying your deposit, you will receive your final letter of acceptance (LOA) to use when applying for your study permit from Immigration Refugees and Citizenship Canada.
- TRU will issue you a PAL on behalf of the Government of BC after your LOA is issued, if you are eligible.
- It is your responsibility to confirm your <u>Canadian study permit eligibility</u> and Canadian Embassy <u>study permit processing times</u> in your country. Study permits must be confirmed by December 1, 2025 to be eligible for registration.
 - o Please upload your study permit <u>here</u>. (Do not send an email regarding your visa approval, use only this link to update the approved status).
 - o Failure to submit the study permit using the link may result in ineligibility to register or defer.
- We reserve the right to defer your admission to the next available semester if deadlines are missed or capacity is reached.

STUDY PERMIT PROCESSING WITH BORDERPASS

- To ease the process of applying for a study permit and visa, TRU has partnered with BorderPass to provide all international students access to trusted Canadian immigration lawyers and services. Experienced Canadian immigration lawyers at BorderPass will review and submit the study permit application to IRCC on your behalf. TRU will cover BorderPass' service fees at no cost to you.
- Instructions on how to use BorderPass will be provided to you along with your final letter of acceptance (LOA). Learn more at tru.ca/borderpass.

HOUSING

- You should wait until you receive your study permit confirmation before booking fights or making significant life changes like leaving your job. If you do so, it is at your risk.
- If you are interested in on-campus housing, we recommend you apply as soon as the residences begin accepting applications. Students can <u>book directly</u> with the residence of choice or through <u>TRU World</u> by submitting the full housing fees, along with the tuition and fees.
- Homestay must be booked through TRU World directly.

Tuition

For total program tuition please view our <u>website</u>. Most program durations are based on 9 credits (3 courses) per semester. Plan accordingly. Some <u>programs</u> may require additional credits, semesters, and/or fees. Any outstanding balances are the responsibility of the student at the time of registration each semester. Tuition deposits will be due prior to registration each semester.

Guaranteed Tuition Model (GTM)

TRU's GTM locks in your per credit tuition rate from your first semester to the intended duration of your program plus one year to allow ease of planning and flexibility during your academic journey. For more information, please visit <u>link</u>.

General Fees

General fees are required every semester by all students to cover costs such as library, activity, <u>TRU Student</u> Union, U-Pass (full access pass to city transit) and others.

Health and Dental

Medical Insurance and MSP Premium

International students are required to have <u>medical coverage</u> in Canada. For the first three months, students receive coverage through <u>guard.me</u>. After three months, students are required to sign up for the <u>BC Medical Services Plan</u>.

Refunds and Deferrals

Refunds of deposits will be given upon proof of study permit rejection and an administrative charge of \$200 will be deducted. Application fees are non-refundable. We recommend students to be familiar with the New Student Tuition Refund Information prior to submitting a payment. If you are not able to start as planned, you can request a deferral.

REFUND AND DEFERRAL INFORMATION FOR NEW INTERNATIONAL STUDENTS

REFUND OF DEPOSIT

Deposits are **non-refundable and non-transferable**. It is the responsibility of the student to read and understand the refund information, important deadlines below, and to plan and budget accordingly.

Students who receive a visa and/or study permit along with a final letter of acceptance, must begin their studies at TRU in the semester written on their letter.

New students who can provide official documentation from IRCC (Immigration, Refugees and Citizenship Canada) indicating that their visa and/or study permit application was denied, are eligible for a full refund of their deposit less a \$200 administrative fee. Documentation must be issued by IRCC later than the current letter of acceptance from TRU.

Requests for refunds due to visa rejections must be submitted prior to the <u>course change period deadline</u> to avoid a deposit forfeit. Thompson Rivers University (TRU) reserves the right to contact IRCC to verify the status of a visa and/or study permit application and/or to verify the contents of a refusal letter.

To submit a refund request:

- 1. Complete the <u>refund request form</u>.
- 2. Submit your refund request form, along with IRCC documentation, to international admissions.
- 3. Wait for an email from PayMyTuition to confirm how you want your refund payment processed.

Refunds may take 4-6 weeks to be processed.

ADMISSION DEFERRALS

After receiving a letter of acceptance issued by TRU, all new international applicants are expected to begin their studies at TRU in the semester noted in their current letter of acceptance. Students who do not receive a study permit decision prior to the visa confirmation deadline are required to request a deferral.

Students that wish to defer their first semester of study to a future semester may do so within one year of your original admission (ie. a student accepted to the fall semester may defer until the next fall semester but not later). Students must <u>request a deferral</u> prior to the <u>course change period deadline</u> to avoid a deposit forfeit. After one calendar year, a student must reapply if they wish to commence studies at TRU.
