This program serves as the gateway to a professional career in aviation, providing comprehensive training to equip graduates with the necessary skills and knowledge to excel as commercial pilots in Canada.

The PPL & CPL program at Western Community College starts with the Private Pilot License (PPL) program, which includes 40 hours of Private Pilot Aeroplane Ground School (PPL101) and 45 hours of Private Pilot Flight Training in Aeroplanes (PPL102). This program focuses on providing comprehensive training that enables graduates to fly Canadian registered airplanes worldwide during daylight hours (Day-VFR) while maintaining visual contact with the ground. Upon successful completion of this program, students will be qualified to fly aircraft up to 12,500 pounds with as many passengers as the aircraft is certified to carry and will progress to start their Commercial Pilot License (CPL) program.

The CPL program includes 80 hours of Commercial Pilot Aeroplane Ground School (CPL101), 65 hours of Commercial Pilot License Flight Training in Aeroplanes (CPL102), 90 hours of time building and 20 preparatory hours (PREP). Admission Requirements:

You have fulfilled the following admission requirement:

Students need to be a minimum of 18 years old.

However, this offer is conditional based on the fulfillment of the following requirements (if not already met):

- Pass the Aviation English Language Proficiency Test (ELPAT) conducted by Western Community College, it is mandatory to clear the ELPAT before the start of your program.
- CAT 4 or higher Aviation Medical Certification, it is mandatory to clear this medical evaluation before the start of your program.

Note:

- If you are applying for this program from outside of Canada, it is highly recommended to get your medical certification done from your home country before arriving.
- Additionally, if you are not a Canadian Citizen or a Permanent Resident, you must apply for a Study Permit (visa) in order to study in Canada. Our past experiences showed that applicants who obtain an IELTS band score of at least 6.0 have greater chances of having Study Permits approved by IRCC.

Learning Objectives:

Private Pilot License (PPL) program:

Upon program completion, you will be able to serve as a pilot-in-command or co-pilot of an airplane with appropriate ratings, pilot ultra-light aircraft, fly single-engine airplanes with passengers, and obtain Canadian Registered airplane flying privileges worldwide. Throughout the program, your progress will be assessed through various exams and tests, including ROC-A, PSTAR, English Language Proficiency exam, PPAER, and Flight Test.

Commercial Pilot License (CPL) program:

Upon successful completion of this program, student will possess the capabilities to fly for compensation or hire, operate under VFR Over the Top (VFR OTT) conditions, serve as Pilot in Command (PIC) in commercial air operations on any class and type of airplane endorsed on their license that does

not necessitate more than one pilot, and act as a co-pilot on any class or type of airplane endorsed on their license, irrespective of the required crew size for operations.

- To successfully complete the program, you must pass the PPAER exam with a minimum of 60% marks and receive a "Pass" from the Designated Flight Test Examiner (DFTE) on the Flight Test.
- CAT 3 Aviation Medical Certification
- Your progress will be assessed through a series of exams, including the CPAER exam, which serves as the final exam for the ground school course, and the Flight Test, which ensures your flying skills meet the required standards.

Commercial Pilot License (CPL) program:

- Your progress will be assessed through a series of exams, including the CPAER exam, which serves as the final exam for the ground school course, and the Flight Test, which ensures your flying skills meet the required standards.
- CAT 1 Aviation Medical Certification
- To successfully complete the program, you must pass the CPAER exam with at least 60% marks and receive a "Pass" from the Designated Flight Test Examiner (DFTE) on the Flight Test.

Program Duration:

Private Pilot License (PPL) program:

The program spans a total of 6-8 months and includes a minimum of 45 hours of flight training and 40 hours of ground school instruction.

Commercial Pilot License (CPL) program:

The program spans a total of 12-14 months and includes a minimum of 65 hours of flight training, 80 hours of ground school instruction, 90 hours of time building and 20 preparatory hours.

Homework Hours:

Participants should dedicate 3-4 hours of self-study daily outside of the classroom and In-Flight Instructions provided during the course.
