The non-refundable seat deposit is equivalent to the normal 15-week semester program tuition regardless of your semester start date. International students who are enrolled and withdraw after the semester begins will also forfeit college fees. This amount is non-refundable under any circumstance, except for study permit refusals.

One requirement of the Associate of Arts degree is the successful completion of one college level Math course, one lab science, and one open science course in any semester of the program. Depending on the Math/Science courses chosen, if you do not meet the prerequisite requirement, you may be required to take an upgrading course. The cost of an upgrading course is currently \$1,395.00, and this charge is due in the semester you take this course.

***You will not be offered a seat in this program until all conditions are met.***

Seats in the Associate of Arts degree program are limited, and are filled on a first come, first served basis. Should all seats in this program be filled before we receive your first semester tuition and fee payment, you will automatically be placed on the waitlist.
