Study Permit Approval

To confirm your seat, you must submit proof of your valid study permit approval to <u>ieadmissions@vcc.ca</u> by March 15, 2026. You may submit a copy of your Canadian Study Permit with Vancouver Community College listed on it as the Designated Learning Institution or a copy of your IRCC Port of Entry (POE) letter. Failure to submit proof of approval by this date may result in your seat being offered to another student. If your Study Permit is in process or not approved by this date, you may be deferred to the next available intake.
