International students seeking a study permit to attend a postsecondary learning institution in Ontario must attend a postsecondary institution designated by Ontario for the purposes of the Immigration and Refugee Protection Regulations (Canada). When reviewing an institution's application for designation under the ISP, Ontario's Ministry of Colleges and Universities (the "Ministry") conducts a site assessment to verify the information in the institution's application with respect to its educational policies and procedures. The Ministry may also monitor institutions that are designated to determine whether those institutions are complying with the terms and conditions of designation.

As part of the site assessment and the Ministry's ongoing monitoring of designated institutions, the Ministry reviews a representative sample of student and prospective student records, such as student and prospective student contracts, registration forms, records of enrollment, documents pertaining to academic assessment and progress, and other documents contained in the student or prospective student file. The Ministry also may need to make copies of student and prospective student records in order to complete its review of the institution's (1) application for designation or (2) ongoing compliance with the terms and conditions of designation.

Your consent is requested to allow the Ministry to access the personal information you have provided to the institution that may be contained in your student records. Written notification is required for all cancellations and withdrawals. Refunds will be based on the date of receipt of the official written notification. Refunds may take up to 30 business days to process.

2a. Domestic Students

Prospective domestic students who decide not to start their program or withdraw from course(s) up to the DROP/ADD deadline of the term receive a 100% refund of all monies paid, excluding:

- non-refundable application fees;
- non-refundable program or registration fees;
- withdrawal processing fee; and,
- any other non-refundable fees as identified in the UNF Calendar.



2b. International Students

Prospective international students who have been issued a Letter of Admission (LOA) or a Conditional Letter of Admission (CLOA) and who decide not to start their program or who withdraw from their registered course(s) on or before the drop/add deadline for the term will receive a refund ONLY if their student visa or study permit is denied by Immigration, Refugees, and Citizenship Canada (IRCC). Any refund of a required initial deposit (first term's tuition and compulsory fees), will exclude:

- non-refundable application fees;
- non-refundable program or registration fees;
- withdrawal processing fee;
- wire transfer fee; and,
- any other non-refundable fees as identified in the UNF Calendar.

Prospective International students will NOT be eligible for a refund and the initial deposit fee (first term's tuition and compulsory fees) will be forfeited and retained by UNF if:

their student visa is denied by IRCC due to misrepresentation (directly or indirectly misrepresenting or withholding material facts) or by providing false or misleading information or documentation.

the student or his/her representative misrepresents (directly or indirectly misrepresenting or withholding material facts) or provides false or misleading information or documentation to the University of Niagara Falls Canada.

3. Wire Transfers

Any refunds to International students which are provided via wire transfer will have a \$35 processing fee deducted from the refund total.

4. University Limited Financial Liability

The University's financial liability in relation to the student's enrolment is strictly limited to the tuition paid by or on behalf of the student and the refund policy. For greater certainty, the University is not liable for any other cost or loss (direct or indirect) of any kind whatsoever, including, but not limited to, the result of the cancellation or delay in the offering of acourse or program, except as provided for through the applicable tuition refund policy. Students should note that any tuition payments received by the University from a government program, an agency, or a person other than the student will be refunded, on behalf of the student to that government, agency, or other person.

5. Medical Insurance

Should an international student request to opt-out of their provided medical insurance coverage, they will be required to demonstrate proof of active medical insurance in Canada (Ontario Health Insurance Plan (OHIP), Private Medical Insurance coverage, etc.).

Domestic students are not eligible to apply for Guard.me insurance. International students in a formal online program may not be eligible to apply for Guard.me. All students residing in British Columbia must have BC's MSP.
